Changes at HUD

Department of Housing and Urban Development (www.hud.gov)

In advance of the announcement of the new SuperNOFA (Super Notice of Funding Availability), the agency has released the notice of changes that will apply to the FY2008 program. HUD is joining the other 25 federal funding agencies in the move to Grants.gov which means that anyone applying for an HUD grant will have to do so at the Grants.gov portal. HUD will follow the move to Adobe on the Grants.gov site. Potential applicants are cautioned that the must use Adobe and that they must use the correct *version* of Adobe (8.1.2) – or risk having their application rejected. HUD says the forms are compatible with the Microsoft Windows Vista operating system, Apple Macintosh computers and Microsoft Office 2007. While HUD urges the use of Adobe 8.1.2, users are cautioned that they must comply with Grants.gov requirements and use "the latest compatible version available." NIH moves closer to new grantmaking process

The National Institutes of Health last week moved closer to revamping its grantmaking process as officials zeroed in on the major kinks in the system and outlined coordinated approaches to correcting them.

The effort is aimed at adapting NIH's increasingly burdened peer review system – long seen as the gold standard in judging the best research – to rapid changes in the biomedical and behavioral sciences and demands for funding. NIH estimates receiving 80,000 applications this year.

A major concern is the ability to nurture new investigators to ensure the future biomedical and behavioral science workforce. Success rates for new investigators are lower than those for established scientists at every stage of the application process for research project grants.

Addressing those issues, a key working group summarized the challenges in a draft report. NIH needs to:

- Reduce the administrative burden of applicants, reviewers and NIH staff (by reducing the number of applications);
- Enhance the rating system (to highlight priority criteria);
- Enhance review and reviewer quality (to focus on proposal impact and innovation);
- Optimize support at different career stages and types (to enhance support for new investigators and enable greater productivity of established scientists);
- Optimize support for different types and approaches of science (to foster transformative research);
- Reduce the stresses on the support system of science (to ensure best use of NIH resources);
- Provide for continuous review of peer review.

Recommendations to meet the challenges range from shortening applications to using “prebuttals” to allow applicants to correct factual errors prior to review (see page 8). NIH said it will assemble an implementation team four to six weeks following finalization of the draft report to plan pilot testing recommendations.

Grantees may see a return to cost-sharing at NSF

The National Science Board has recommended that the National Science Foundation return to requiring grantee cost-sharing under certain programs.

In the first of two reports requested by Congress, the NSB, NSF's policy arm, said NSF should selectively reinstate mandatory cost-sharing. The board said the decision to

eliminate the practice agency-wide in 2004 had unintended consequences and undermined program goals.

The activities in question include: the Engineering Research Centers program; the Experimental Program to Stimulate Competitive Research; and the Industry/University Cooperative Research Centers program.

These programs call for building regional, state or institutional capacity; creating partnerships with industry; and promoting sustainability of activities beyond the grant. Those features are increasingly important in light of the current emphasis on scientific and economic competitiveness.

But the board said removal of cost-sharing “virtually eliminated the incentive for participation by industry” and hampered the ability of the programs to meet their goals.

NSF banned cost-sharing due to concerns that the practice was biasing award decisions and interfering with objective review of applications on the basis of scientific merit. Grantees complained that cost-sharing unfairly discriminated against less well-heeled institutions.

NSB conceded that cost-sharing “presents significant challenges,” not the least “efforts to broaden participation in science in federally sponsored research are hindered.” Nevertheless, NSB urged NSF to investigate ways to foster industrial participation features; define and communicate principles to guide cost-sharing; and train program officers “to avoid unintended implicit or explicit requests for voluntary cost-sharing...during the budget negotiation process.” A more comprehensive report will be issued later this year.

The PA seeks the submission of high-quality observational studies that evaluate the effectiveness and cost-effectiveness of complementary and alternative medicine approaches used in the community, and the decision processes employed by patients and providers in deciding to use them. Over the last 10 years, there has been an appreciable increase in research that studies the efficacy and the biological basis form many therapies that are called Complementary and Alternative Medicine (CAM). At the same time, very little

research has been done to see how CAM is used in a “real world” setting. NCCAM has identified as a high priority studies that examine effective and cost-effective use of CAM as practiced in community settings to assuage the gaps in our knowledge about CAM use. NCCAM seeks a broad array of studies that will provide the center with a range of information regarding “CAM treatments in the manner in which they are practiced” including clinical outcomes, cost-effectiveness, patient-provider communication, and the decision-making process (patient and provider) in deciding to incorporate CAM into a patient’s healthcare plan.

This RFP seeks studies that show how CAM therapies function in actual healthcare settings, where patients may have multiple problems and utilize multiple therapies, both CAM and conventional. It places emphasis on observational studies and secondary data analyses evaluating the use of CAM in real-world settings. Examples of the types of projects this initiative could support include case-control studies, retrospective observational studies, secondary analyses of existing data, and prospective observational studies. Projects wherein the investigators assign participants to specific therapies or groups of therapies are not allowed under this RFP. Eligible PI’s include any person who has the skills, knowledge, and resources necessary to carry out the proposed research in cooperation with their institution/organization. Proposed studies must address one of the following topics: evaluations of policy or environmental interventions and strategies for increasing physical activity and/or reducing sedentary behaviors among youth; studies of the interactive effects of built environment and social/cultural factors on youth physical activity and/or sedentary behaviors in populations at high risk for obesity; studies of the economic determinants and/or impacts of environments and policies that affect youth physical activity and/or sedentary behaviors; and analyses of macro-level policies and environmental-change strategies with the potential to increase physical activity and/or reduce sedentary behaviors among youth.

Approximately \$3.3 million will be awarded for research grants exploring the four topics, as well as dissertation grants. Research grants will range from \$50,000 to \$400,000 each, for projects ranging from twelve to thirty-six months. Dissertation awards will provide up to \$25,000 each.

Preference will be given to applicants that are either public entities or nonprofit organizations that are tax-exempt under Section 501(c)(3) of the Internal Revenue Code. Applicant organizations must be based in the United States or its territories.

NEH Fellowships at Digital Humanities Centers (FDHC) support collaboration between digital centers and individual scholars. An award provides funding for both a stipend for the fellow while in residence at the center and a portion of the center's costs for hosting a fellow. Awards are for periods of six to twelve months. The intellectual cooperation between the

visiting scholar and the center may take many different forms and may involve humanities scholars of any level of digital expertise. Fellows may work exclusively on their own projects in consultation with center staff, collaborate on projects with other scholars affiliated with the center, function as “apprentices” on existing digital center projects, or any combination of these. The results of the collaboration may range from “proof of concept” to finished product. The aims of the program are to 1) support innovative collaboration on outstanding digital research projects; 2) expand digital literacy and expertise; 3) promote the work of digital humanities centers; and 4) encourage broad and open access to the humanities. FDHC grants are made to digital humanities centers and, therefore, a staff member of the digital humanities center must serve as the project director. Prospective fellows must apply through a digital center. Centers may submit one application per deadline; individual scholars may apply in collaboration with only one digital center per deadline. Awards support the scholar's fellowship in residence as well as a portion of the center's direct and indirect costs of hosting such fellowships.
